The Board of Trustees will conduct its Regular Board Meeting remotely as authorized by the Governor's Executive Order 2020-07, and as extended by subsequent Executive Order, and the Attorney General's Guidance to Public Bodies during the COVID-19 Pandemic. Profanity or obscene words contained in Public Comments will not be read out.
