

**ORDINANCE NO. 2018-OR-09
HARVEY PUBLIC LIBRARY DISTRICT**

**ORDINANCE FOR THE LEVY AND ASSESSMENT OF PROPERTY TAXES
FOR THE FISCAL YEAR COMMENCING JULY 1, 2018 AND ENDING JUNE 30, 2019**

WHEREAS, the President and Board of Library Trustees of the Harvey Public Library District, in Cook County, Illinois (the "Board of Library Trustees"), did on September 13, 2018, adopt the Annual Budget and Appropriations Ordinance (Ordinance No. 2018-OR-08) for said Library District for the Fiscal Year beginning July 1, 2018 and ending June 30, 2019, pursuant to the Illinois Municipal Budget Law, 50 ILCS 330/1, *et seq.*, and the Illinois Public Library District Act of 1991, 75 ILCS 16/1-1, *et. seq.*; and

WHEREAS, the Board of Library Trustees did then ascertain and determine the total amount of the appropriation made for all purposes permitted by the Illinois Public Library District Act of 1991 and the total amount of monies necessary to be raised by taxation for the appropriation in the 2018 levy year, taking into consideration monies to be raised from other than tax sources; and

WHEREAS, the Board of Library Trustees has determined that the total sum required to be levied in the 2018 levy year for the current fiscal year for the necessary purposes of the Harvey Public Library District is \$1,534,700.00, an aggregate levy that does not exceed a 5% increase over the prior year's extension.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF LIBRARY TRUSTEES OF THE HARVEY PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS, as follows:

SECTION 1: That the total sum of **one million five hundred thirty-four thousand seven hundred dollars (\$1,534,700.00)**, composed as specified below, be and the same is hereby levied and assessed upon and against all taxable property within this Library District according to the full fair value as established and ascertained for State and County purposes for the Fiscal Year beginning July 1,

2018, and ending June 30, 2019, and the Board of Library Trustees, having on September 13, 2018, duly adopted the Annual Budget and Appropriation Ordinance for the Fiscal Year beginning July 1, 2018, and ending June 30, 2019 (Ordinance No. 2018-OR-08), finds that the specific purposes and the specific amounts provided for in said Annual Budget and Appropriation Ordinance No. 2018-OR-08, which Ordinance is by this reference made a part hereof and incorporated herein, are required to be levied for the necessary purposes of the Harvey Public Library District.

SECTION 2: That the total sum of **one million five hundred thirty-four thousand seven hundred dollars (\$1,534,700.00)**, having been ascertained as aforesaid stated, is composed as follows:

SECTION 3: The Secretary of the Board of Library Trustees of the Harvey Public Library District is hereby authorized and directed to file with the County Clerk of Cook County, Illinois, a duly certified copy of this Ordinance for the Levy and Assessment of Property Taxes for the Fiscal Year Commencing July 1, 2018 and Ending June 30, 2019 on or before the last Tuesday in December 2018; and that said County Clerk of Cook County, Illinois is hereby authorized and directed to extend the said tax so levied by this Ordinance, according to law, against all taxable property within the Harvey Public Library District.

SECTION 4: This Ordinance shall be in full force and effect from and after its adoption as provided by law.





**RESOLUTION NO. 2018-RS-07
HARVEY PUBLIC LIBRARY DISTRICT**

RESOLUTION DIRECTING REDUCTION ALLOCATION FOR 2018 AGGREGATE EXTENSION

WHEREAS, the Board of Library Trustees of the Harvey Public Library District, Cook County, Illinois, has heretofore levied and assessed taxes upon and against all taxable property within this Library District for the 2018 tax levy year and certified such levies to the County Clerk of Cook County, Illinois; and

WHEREAS, pursuant to the Property Tax Extension Limitation Law (“PTELL”), if the County Clerk is required to reduce the aggregate extension of a taxing district by the provisions of PTELL, the County Clerk shall proportionately reduce the extension for each fund unless otherwise directed by the taxing district; and

WHEREAS, a reduction of the aggregate extension heretofore levied by the Board of Library Trustees by proportionally reducing the extension for each levy fund of the District may not be in the best interests of the District; and

WHEREAS, PTELL allows the Library District to request that the County Clerk of Cook County reduce the aggregate extension other than by a proportional reduction of the extension for each levy fund of the District.

NOW THEREFORE, BE IT BE RESOLVED by the Board of Library Trustees of the Harvey Public Library District, Cook County, Illinois, as follows:

SECTION 1: The Board of Library Trustees hereby finds and determines that, should the aggregate extension of the Harvey Public Library District for 2018 need to be reduced by provisions of PTELL, the method for the reduction in the aggregate extension of the District for the 2018 tax levy, including the allocation of reduction among the various funds of the District, shall be as follows:

A. The Board of Library Trustees directs that the Cook County Clerk **shall proportionately** reduce the extension for each of following fund(s):

Illinois Municipal Retirement Fund
Social Security
Auditing
Liability Insurance
Worker’s Compensation

Unemployment Insurance

- B. The Board of Library Trustees further directs that the Cook County Clerk **shall not** reduce the following fund(s), except for amounts over the fund rate limit:

Corporate

SECTION 2: This Resolution shall be in effect forthwith upon its passage and approval as provided by law.


